## OIL SANDS INFORMATION BULLETIN 2006-05

### **SUBJECT: New Oil Sands Royalty Information Bulletin Subscription List**

The Oil Sands Business Unit (OSBU) sends Information Bulletins to royalty clients to provide notification of general information relating to administration of Crown Oil Sands Royalty, proposed changes to legislation or regulations, and changes in procedures.

To improve communication with industry, the OSBU has created a new *Oil Sands Royalty Information Bulletin* (Royalty IB) subscription email list. The Royalty IB supplements the Information Bulletins available on the Oil Sands homepage and requires a separate subscription from the Oil Sands Information Letter subscription list. Subscribing to the Royalty IB email list will automatically provide clients with the Royalty IB at the same time it is posted to the DOE website.

Clients requiring Oil Sands Royalty Information Bulletins may subscribe to this new feature by navigating to the Oil Sands homepage from the Department of Energy website [www.energy.gov.ab.ca](http://www.energy.gov.ab.ca). (Navigation instructions - In the left menu find and click on *Our Business, Oil Sands, On-line services*, and then click on the topic *e-subscriptions*.)

There will be a transition period where OSBU will send the Oil Sands Royalty Information Bulletins using both the Information Letter list, and the new Royalty IB list; therefore, you may receive the same bulletin twice during this time. Effective September 1, 2006, the department will only send the Oil Sands Royalty Information Bulletin via the new Royalty IB subscription email list.

More than one contact per company can subscribe. It will be each individual contact's responsibility to keep the email address current. You may unsubscribe at any time using the *unsubscribe* link.
